Stifel Charity Classic presented by Compliance Solutions announces 2024 charitable giving

OFFICIAL PGA TOUR CHAMPIONS EVENT SURPASSES \$3.4 MILLION IN CHARITABLE DONATIONS SINCE ITS INCEPTION IN 2020

ST. LOUIS (February 6, 2025) – Tournament officials announced today that the fourth playing of the Ascension Charity Classic (now named the Stifel Charity Classic presented by Compliance Solutions), concluded September 8, 2024, raised more than \$800,000 for charitable organizations in North St. Louis County and beyond. The total includes \$200,000 for each of the tournament’s 2024 primary beneficiaries, Marygrove, Boys & Girls Clubs of Greater St. Louis (BGCSTL), and Urban League of Metropolitan St. Louis (ULMSTL).

Together with additional charitable donations from tournament events, including the Charity Putting Challenge presented by Compliance Solutions and Folds of Honor Friday presented by Compliance Solutions, the Stifel Charity Classic’s overall giving amount since its inception in 2020 now exceeds \$3.4 million.

“What this tournament has accomplished for charitable organizations right here in our hometown of St. Louis is incredible,” said Ron Kruszewski, Chairman and CEO of Stifel. “We are proud to continue to grow the philanthropic mission that Ascension established from the inception of this event to foster positive and enduring change in our community. Charity and civic pride align perfectly with our core values and will remain the foundation of the Stifel Charity Classic and our strong commitment to benefiting the communities in which we live, work and play.”

The fifth playing of the official PGA TOUR Champions event will take place the week of September 1–7, 2025 at Norwood Hills Country Club.

The tournament’s founding title sponsor, Ascension, will transition into a new role with the Stifel Charity Classic beginning in 2025 as a proud partner and continue to support the tournament. Ascension has been a driving force behind the success and growth of the tournament from the beginning, including the event’s commitment to charity.

“St. Louis’s official PGA TOUR Champions event at Norwood Hills Country Club delivered a fantastic 2024 tournament,” said Eric Engler, Ascension EVP and Chief of Staff. “The real winners of the tournament have always been charity, and that remained true to form as the fourth annual event continued its focus on philanthropy and community. The tournament provides an incredible platform to give back, and as we shift into our new proud partner role with the Stifel Charity Classic, Ascension is looking forward to continuing to help make a difference for the youth and families in the Greater St. Louis area.”

The Stifel Charity Classic proudly stands as a premier event on PGA TOUR Champions, but it is much more than a golf tournament. The events and activities associated with the Stifel Charity Classic provide an all-inclusive,

The Stifel Charity Classic is a Regular Season PGA TOUR Champions event in 2025, which will give way to the Charles Schwab Cup Playoffs—a season-ending, three-tournament series used to determine the TOUR's season-long champion. The 2025 PGA TOUR Champions schedule features 28 events and will conclude with the Charles Schwab Cup Championship in Phoenix, AZ. The 2025 Season will have players competing for more than \$69 million in total prize money, the highest in PGA TOUR Champions' 45-season history.
